### **AIRPORT COMMISSION MINUTES**

#### **02. AIRPORT REHABILITATE RUNWAY LIGHTING & NEW AIRFIELD LIGHTING VAULT CLOSEOUT**

Commissioner Brotherton motioned to approve Resolution No. A100-1-2022 Accepting the Airport Rehabilitate Runway Lighting and New Airfield Lighting Vault Project and Submit Closeout Documentation to the Federal Aviation Administration. ### **03. AIRPORT PROJECTS UPDATE**

Airport Director Dalsing mentioned that the Airport FY23 budget presentation to the City Council will be held on March 3rd. Staff is continuing to work with Federal Legislators to secure funding for replacement of the aircraft tower. IPAA Day on the Hill is scheduled for February 15<sup>th</sup>. A live fire drill exercise will be held in April as well as the Run the Runways event with University of Dubuque. Two Honor Flights are being planned for May.
