CASE #1 EXTENSION OF TIME
Applicant: Ronald McDonald
Location: 548 W 7th St
Appeal: Delay demolition of property

Mike Belmont provided the staff report. Lynn Sutton motioned to approve the extension of time for demolition of 548 W 7th St. Mary Gotz seconded. Motion failed 4-0.

CASE #2 INTERPRETATION OF THE CODE
Applicant: TKWJ Estates LLC
Location: 2535 Central Ave #12
Appeal: City precedent of interpretation when tenant is responsible for damages

Mike Belmont provided the staff report. David Lindecker stated his tenant admitted to breaking the shelf and asked for clarification on how far a tenant can push damages they cause onto the landlord. Tenant Amilleon Brand showed a video and stated her refrigerator died in March 2022 and a used one was provided. The used one was not clean and while cleaning it broke the shelf. After further information was provided, Mr. Lindecker withdrew his appeal and said he would replace the refrigerator.
